Additional Hours Attendance

A charge of £10.00 per hour is made for any additional hours in attendance.

Government Funding Entitlement

All **15** Funded hours will be applied to original booking sessions upon joining the Nursery, however if your child receives the extended 30 hours this can **only** be applied on a 10-hour day as per below. If you would like your child to attend between 7.30 am – 8.30am this can be added as per the additional hour cost.

Additional Daily Supplements are added to funded hours only.

Funded hours are term time only. Full Fees apply during half terms.

Notes

*Fees are paid monthly in advance. You will receive invoices at the beginning of each month. Payments can be made by Cash, Cheques or BACS. Fees are due in full by the 14th of the month before the next month's invoices are generated.

Please note that a penalty charge of £50.00 will be made for late payments. Please speak to Elly for further information.

*No Charge is made for Christmas Closure, Training Days or Bank Holidays.

*10% Sibling Discount is given.

* Fees are payable during the period of sickness absence, although long-term illness may be able to be negotiated, dependent on circumstances.

*Non funded children will receive one week of sessions at a 50% discount for Holiday leave taken during **term time**. We must however be given at least four weeks' notice of the dates in question. For example, if a child attends 3 days per week, they will be permitted 3 days holiday leave at 50% fees each year. *Funded children who attend over their funded hours will receive 50% off one week of non-funded holiday days during term time.*

*Non funded children will attend extra-curricular clubs each week at no extra cost. Extra-Curricular clubs start from our Squirrels room onwards.

*Normal fees will also be charged in the holidays to those two/three-year-old children receiving term time Government funding, as holiday periods are not covered. Three-year funded children have the option to be term time only. This does not apply to under threes.

*Childcare Vouchers and Tax-free childcare payments are accepted.

*There is no charge for parents working in Schools for non-attendance during School holidays, however a retainer or £100.00 is payable in July each year to secure your child's place for the following September.

Should part time attendance be required during the school holidays this can be arranged and will be charged at the full daily rate. For families with 2 or more children attending the Nursery the retainer will be £100.00 for the first child and £50.00 for siblings.

*A Booking Fee of £60.00 is required to secure a place, which is non – refundable but covers the full three week settling in period.

*A Booking Fee for Government Funded only sessions of £30.00 will be required, however will be refundable if place is secured and required.

*All meals booked must be paid for regardless of whether you bring your child that day, unless at least one weeks' notice is given.

*Fees will be reviewed every June/July, ready for a September start. We will notify you of this well in advance and will be displayed on our website.

Help with childcare costs

Working Tax Credit and Universal credit

Working Tax Credit and Universal Credit are paid to people in work to top up low wages. This includes earnings from employment and earnings if you are self-employed.

Disability Access Fund

If your child is three or four years old and receives free childcare, and is in receipt of Disability Living Allowance, you can apply for your childcare provider to receive a small amount of funding through the Disability Access Fund (£615 per year). This is to help your childcare provider make reasonable adjustments at their setting to improve your child's access.

Disability Living Allowance

Disability Living Allowance (DLA) is the main source of financial support available for the additional costs faced by disabled children. Your child may qualify for DLA if they have a physical disability and/or SEN, and require more help or supervision, than other children of the same age.

Childcare Vouchers

They're a Government-approved, tax-efficient way of paying for childcare. If you join the scheme, you can exchange up to £243 a month (£55 a week) of your gross salary for childcare vouchers. The part of your gross salary you exchange for childcare vouchers is tax-free and exempt from National Insurance contributions (NI). Because of this, you can make savings of up to £933* a parent, a year.

Tax free childcare

You can get up to £500 every three months (£2,000 a year) for each of your children to help with the costs of childcare. If you get Tax-Free Childcare, the government will pay £2 for every £8 you pay your childcare provider via an online account.
